



Memorandum of Understanding

This Memorandum of Understanding is made and entered into on 12/08/2019 by and between "TARANATH SHIKSHANA SAMSTHE'S SOMA SUBHADRAMMA RAMAN GOUD WOMEN'S COLLEGE, RAICHUR" and "SHREEJI AGRO TECH INDUSTRIES, RAICHUR" for the purpose of establishing a mutually beneficial relationship and promoting academic and economic collaboration.

Purpose and Scope of Agreement:

The purpose of this MOU is to outline the general terms and conditions for a cooperative relationship between the SSRG Woman's College, Raichur and the Shreeji Agro Tech Industries, Raichur. This agreement is intended to promote educational and economic cooperation between the two organizations.

The scope of this MOU includes, but is not limited to, the following:

- c. Joint seminars, workshops, and conferences related to the field of industry.
- d. The sharing of expertise and resources in the areas of marketing, sales, and distribution of rice products.
- e. Real Time experience about the industry.

Responsibilities of the College:

The College agrees to:

- a. Provide students with opportunities to participate in internships and work-study programs at the Rice Mill.
- b. Provide faculty and staff with opportunities to collaborate with Rice Mill personnel on development projects related to rice milling and processing.
- c. Share expertise and resources related to marketing, sales, and distribution of rice products.

Responsibilities of the Mill:

The Mill agrees to:

- a. Provide students with opportunities to participate in internships and work-study programs at the Mill.
- b. Collaborate with faculty and staff to conduct events.
- c. Share expertise and resources related to the latest developments in the field of rice industry and its marketing.
- d. Offer Placements as per the requirement.

Intellectual Property:

Any intellectual property arising from collaborative research and development projects will be jointly owned by the SSRG Woman's College, Raichur and the Shreeji Agro Tech Industries, Raichur and will be subject to a separate agreement between the two organizations.

Confidentiality:

The SSRG Woman's College, Raichur and the Shreeji Agro Tech Industries, Raichur agree to maintain confidentiality regarding any proprietary or confidential information disclosed to each other under this MOU.

Termination:

This MOU may be terminated by either party upon thirty (30) days written notice to the other party.

Governing Law:

This MOU shall be governed by and construed in accordance with the laws of the state in which the College is located.

Entire Agreement:

This MOU constitutes the entire agreement between the parties and supersedes all prior negotiations, representations, or agreements, whether written or oral, related to the subject matter of this MOU.


Amendment:


This MOU may be amended or modified by the mutual written consent of the parties.
