MEMORANDUM OF UNDERSTANDING BETWEEN <u>VEDANTA EDUCATIONAL TRUST</u> AND <u>SSRG WOMEN'S COLLEGE</u>

- 1. <u>Parties</u>. This Memorandum of Understanding (hereinafter referred to as "MOU") is made and entered into by and between the <u>VEDANTA EDUCATIONAL TRUST</u>, whose address is <u>Sree Square Mall</u>, 1st floor, Harihar Road, Raichur, and the <u>SSRG WOMEN'S COLLEGE</u>, whose address is <u>Railway station road Raichur</u>.
- 2. <u>Term of MOU</u>. This MOU is effective upon the day and date last signed and executed by the duly authorized representatives of the parties to this MOU and the governing bodies of the parties' respective counties or municipalities and shall remain in full force and effect for not longer than <u>THREE YEARS</u> 2017-2020 This MOU may be terminated, without cause, by either party upon <u>One Moth of</u> written notice, which notice shall be delivered by hand or by certified mail.
- 3. <u>Responsibilities of Jagencies</u>]. 'VEDANTA EDUCATIONAL TRUST' shall train students of 'SSRG WOMEN'S COLLEGE' and try to place them in the local industries/businesses in exchange of minimal fees.

4. General Provisions

A. Amendments. Either party may request changes to this MOU. Any changes, modifications, revisions or amendments to this MOU which are mutually agreed upon by and between the parties to this MOU shall be incorporated by written instrument, and effective when executed and signed by all parties to this MOU.

- B. Applicable Law. The construction, interpretation and enforcement of this MOU shall be governed by the laws of the State of <u>Karnataka</u>. The courts of the State of <u>Karnataka</u> shall have jurisdiction over any action arising out of this MOU and over the parties, and the venue shall be the <u>Raichur District</u>, <u>Karnataka</u>.
- C. Entirety of Agreement. This MOU, consisting of <u>three</u>, pages, represents the entire and integrated agreement between the parties and supersedes all prior negotiations, representations and agreements, whether written or oral.
- **D.** Severability. Should any portion of this MOU be judicially determined to be illegal or unenforceable, the remainder of the MOU shall continue in full force and effect, and either party may renegotiate the terms affected by the severance.
- E. Third Party Beneficiary Rights. The parties do not intend to create in any other individual or entity the status of a third party beneficiary, and this MOU shall not be construed so as to create such status. The rights, duties and obligations contained in this MOU shall operate only between the parties to this MOU, and shall inure solely to the benefit of the parties to this MOU. The provisions of this MOU are intended only to assist the parties in determining and performing their obligations under this MOU. The parties to this MOU intend and expressly agree that only parties signatory to this MOU shall have any legal or equitable right to seek to enforce this MOU, to seek any remedy arising out of a party's performance or failure to perform any term or condition of this MOU, or to bring an action for the breach of this MOU.
